## ORDER

University had invited applications for Continuation of Provisional Affiliation for the Academic Year 2023-24 from the colleges affiliated to the University vide paper read above and accordingly, the Principal, Nehru College of Nursing, Ottapalam, Palakkad (N112) has submitted the application for Continuation of Provisional Affiliation to conduct the courses with intake mentioned against each in para (3).

2) Accordingly, University conducted inspection at the College in order to verify the facilities available for granting Continuation of Provisional Affiliation. The scrutiny committee has pointed out certain deficiencies after verifying the inspection reports and the same was intimated to the Principal for rectification.

3) Subsequently, the rectification reports received from the College was placed before the scrutiny committee and the committee recommended to grant Continuation of Provisional affiliation to Nehru College of Nursing, Ottapalam, Palakkad for conducting the courses with intake mentioned in the table below during the academic year 2023- 24 .

4) The college has submitted the renewal permission from Kerala Nurses and Midwives Council, but the suitability from Indian Nursing Council, for the academic year 2023-24 is yet to be obtained.

5) In the circumstances, considering the urgency of admission process to nursing course, sanction is hereby accorded to grant **Continuation of Provisional Affiliation to Nehru College of Nursing, Ottapalam, Palakkad (N112) for conducting the Nursing courses mentioned in para 3 with annual intakes mentioned against each during the academic year 2023-24 subject to ratification by the Governing Council and in anticipation of INC approval. If the intake is reduced by INC, the same shall prevail.**

6) The colleges shall strictly adhere to the general conditions detailed below:-

- a. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Government of Kerala and on the basis of the directions issued by the University from time to time, failing which the Affiliation granted will be cancelled.
- b. In the light of the direction of the Supreme Court of India in Writ Petition (c) 56/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of Affiliation of the College will be initiated.
- c. Affiliation granted is strictly provisional and is only for the Academic Year 2023-24. The college has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex body concerned.
- d. The Colleges shall remit Annual Administration Fee fixed for UG/PG courses for the Academic Year 2023-24.
- e. Admission to the next academic year shall be made only after obtaining prior permissions from the University.
- f. **The college should submit approval order from INC for the academic year 2023-24. If the intake is reduced by INC, the same shall prevail.**
- g. **KNMC registration of all the newly appointed faculty members shall be submitted to the University immediately on receipt of the same.**
